Senator Martin met with various constituents and groups over the month of May to discuss important matters and attend special events. From Asian Heritage month events to the 152nd May Day festival in New Westminster to the Diversity and Inclusion Support Group of BC inauguration ceremony to meeting ambassadors and diplomats of various nations, Senator Martin had a busy agenda working with partners, stakeholders and members of the community. One of the highlights of the month was welcoming members of the Toronto-based Hanca Senior Society to the Senate of Canada, the first in-person group since the start of the pandemic. They were a welcomed sight indeed.

On the Hill...

Parliament Hill was filled with important legislative debate in both Houses of Parliament, insightful testimonies, meetings at parliamentary committees and receptions with various organizations and stakeholders. As Co-Chair of the Special Joint Committee on Medical Assistance in Dying, Senator Martin worked closely with her House Co-Chair MP Marc Garneau and colleagues from both Houses to review the provisions of the Criminal Code relating to medical assistance in dying and their application. In the Senate Chamber, Senator Martin re-introduced her private member's bill S-245 (formerly S-230) An Act to amend the Citizenship Act, to permit certain persons who lost their Canadian citizenship to regain citizenship. The bill received unanimous support once again and was fast tracked to the House of Commons in hopes that the bill will receive royal assent and become law in the near future. As Deputy Leader of the Official Opposition, Senator Martin will continue to work to serve all Canadians and ensure that the government held to account. Senator Martin also welcomed a new Parliamentary intern to her team in Ottawa. Welcome Briand Leda!
